#### 119. **Apologies**

Cllr Walker is unhappy with the delay of the process due to the time restraints of the S.106. The Clerk advised that as the S.106 is a legal agreement, that the Council has to follow this procedure and no monies can be spent until a decision has been made.

Cllr Bestwick suggested the Council invite relevant County Officers to the October Meeting,

### 124. **Christmas Lighting**

The Council discussed the purchase of Christmas lighting for Dobshill. The Clerk informed the Council that FCC have confirmed the street columns have been structurally tested, however, suggested a meeting with members, FCC and Mega Electrical prior to installation.

- iii. No christmas tree will be installed in Dobshill.
